Discount for people in receipt of benefits

The Salvation Army supports initiatives to help people find work and participate as active agents in our common social life. Applicants in receipt of benefits will often be experiencing difficulties in covering their daily living costs, and discounting the fee for people in such circumstances will remove a significant obstacle and disincentive.

The Salvation Army notes, however, that this will be the case only if and when the applicant bears the direct cost of the application.

Furthermore, while supporting this proposal in broad principle, The Salvation Army is opposed to financing these discounts by introducing fees for volunteer applications. The Salvation Army urges the Scottish government to seek other revenue streams to finance this proposal.

Discount for care experienced young people

The Salvation Army recognises that this proposal is designed to encourage care experienced young people to apply for roles which require PVG membership and intends to counter the reluctance they might feel by the prospect of their personal history might be disclosed. The Salvation Army supports initiatives to help people find work and participate as active agents in our common social life, and in broad principle therefore supports the proposals to discount application fees for care experienced young people.

As with the proposal for a discount for those in receipt of certain benefits, The Salvation Army notes that this incentive will take effect only if and when the applicant bears the direct cost of the application.

Furthermore, while supporting this proposal in broad principle, The Salvation Army is opposed to financing these discounts by introducing fees for volunteer applications. The Salvation Army urges the Scottish government to seek other revenue streams to finance this proposal.

Discount for volunteers

The Salvation Army is opposed to this proposal. The proposal is described as a "fee discount". However, since fees are waived for volunteers under the current arrangement, the proposal is really to introduce an additional cost for voluntary organisations, including those linked to churches and faith communities. The Salvation Army has serious concerns that introducing fees for voluntary applications would place many voluntary sector organisations under significant financial pressure and could adversely affect their viability, leading to a significant reduction in the services that the sector offers to civil society. The Salvation Army therefore urges the Scottish government to consider that:

1. The voluntary sector makes a significant contribution to Scottish society. As pointed out in a recent paper from the Royal Society of Edinburgh "third sector organisations can help to reduce public expenditure, either by providing services in health, social care, or education, which the state would otherwise have to provide or by reducing the need to use public services". The introduction of a fee for volunteers, even at the discounted rate proposed,

could increase the financial pressure on third sector organisations, including churches and faith communities, which often have limited financial resources and are already struggling to maintain their services. Many smaller organisations might find that their operations are no longer sustainable. Even in larger organisations, the costs associated with volunteers are often carried by local budgets, which would be placed under extreme financial pressure. There is therefore a serious risk that introducing fees for volunteer applications could lead to a reduction in the services offered by the voluntary sector, with some organisations finding they are unable to continue.

2. The financial pressure that introducing a fee for volunteer applications will place on voluntary sector organisations, including those associated with churches and faith communities, will be further exacerbated by the recurring costs of renewing PVG membership every five years. The consultation document does not set out a clear proposal for this recurring cost, but even if it is fixed at a level equivalent to the current charge for a statement or confirmation of scheme membership, this will represent a significant cost for voluntary sector budgets.

3. Volunteers are, by their very nature, free agents who can withdraw their service at any time. It is not unusual for a volunteer to quickly find that they are not comfortable or suited to the role in which they find themselves. It is therefore more than likely that voluntary organisations would sometimes find that they were paying for volunteer applications which did not then yield the benefit hoped for. The introduction of fees for voluntary applications is especially unwelcome in the light of post-pandemic trends, with many voluntary organisations, including churches and faith communities, reporting significant reductions in the number of people volunteering.

4. While recognizing that the revenue from the proposed fees would cover only a third of the cost of processing volunteer organisations, The Salvation Army is concerned that introducing a fee for volunteer applications might well lead to a significant reduction in the services provided by voluntary organisations, some of which would cease to operate. The likely reduction or cessation of services will in turn have a significant negative effect on those served by the voluntary sector, who are often already facing serious difficulties.

5. The Salvation Army recognizes that this proposal is designed to ensure the future sustainability of discounting fees for applicants in receipt of certain benefits and for care experienced young people. The Salvation Army supports those proposals in principle, but for the reasons set out above, believes that they should not be financed, even in part, by the introduction of fees for volunteer applications. The Salvation Army accordingly urges the Scottish government to find alternative revenue streams to finance these proposals.

These are, however, off-set by the proposals to introduce fees for applications made by volunteers, which may reduce the numbers of volunteers, whether directly in cases where they are asked to defray the cost of the application, or indirectly by placing a burden on voluntary organisations, whose budgets are already under extreme pressure. It should also be remembered that if voluntary organisations find themselves unable to continue providing services, this will negatively affect those whom they support and serve, who are often from groups and demographics who are often experiencing significant deprivation in various forms.
